Instruction to Bidder / Tenderer

- The Bidder is expected to examine all instructions, forms, terms, and specifications in the Bidding Document. Failure
 to furnish all information or authentic documentation required by the Bidding Document may result in rejection of
 the Bid.
- 2. Tender bid can be sent by post/ courier or submitted by hand at our office by time as specified in tender notice.

 Tenders received late will be rejected. (Except in certain case where it has been requested through emails).
- 3. In case tender opening date is declared a Holiday, bids shall be opened on next working day at the same time specified in tender.
- 4. The unit rates and the prices shall be quoted by the Bidder entirely in Indian Rupees unless otherwise specified in Bidding/ Tender document in case of International Competitive Bidding (ICB). All payments shall be made in Indian Rupees only, unless otherwise specified in the Bidding/ Tender document.
- 5. To establish their eligibility, Bidders shall complete the eligibility criteria specified /requested in the Bid/ Tender document.
- 6. Any attempt by a Bidder to influence the Procuring Entity "The Jharkhand State Cooperative Milk Producers' Federation Ltd. (JMF)", in the examination, evaluation, comparison, and post qualification of the Bids or Contract award decisions may result in the rejection of its Bid, in addition to the legal action which may be taken by the Procuring Entity under the Act and the Rules.
- 7. Information relating to the examination, evaluation, comparison, and post-qualification of Bids, and recommendation of contract award, shall not be disclosed to Bidders or any other persons not officially concerned with such process until information on Contract award is communicated to all Bidders.
- 8. To assist in the examination, evaluation, comparison and qualification of the Technical or Financial Bids, the Bid evaluation committee may, at its discretion, ask any Bidder for a clarification regarding its Bid. The committee's request for clarification and the response of the Bidder shall be in writing.
- 9. Any clarification submitted by a Bidder with regard to his Bid that is not in response to a request by the Bid evaluation committee shall not be considered.
- 10. The determination of qualification of a Bidder in evaluation of Technical Bids shall be based upon an examination of the documentary evidence of the Bidder's qualifications submitted by the Bidder and in accordance with the qualification criteria indicated in Qualification and Evaluation Criteria. Factors not included in Qualification and Evaluation Criteria shall not be used in the evaluation of the Bidder's qualification.

- 1.1 The bidder in the same name & style, should be in business at least for three years at the time of bid opening. In case of change of name of the bidder by merger /acquisitions/change in status, the bidder may be eligible based on the documentary evidence.
- 1.2 That, bidder should have valid registration under various act the may be applicable for the proposed contract. This shall include but not limited to Income tax, Companies Act, Goods & Service Tax (GST), Welfare Cess Act apart from any other applicable tax-imposed time to time by State/Central Govt. and Employee State Insurance, Contract Labour, Provident Fund etc.
- 1.3 That, bidder's financial turn-over in the same name & style during each of the last three financial years (2019-20, 2020-21, 2021-22) should not be less than Rs. 5 Crore.

3.0 TERMS AND CONDITIONS

- 3.1 The tenderer should fill its profile in enclosed format -Annexure-I.
- 3.2 The details specification is attached as **Annexure-III**.
- 3.3 The rate to be quoted in the prescribed format enclosed as **Annexure -II** "Financial Bid".
- 3.4 Rates should be quoted on the basis of strict adherence to specifications of WMP and recovery norms of FAT and SNF as given in **Annex –II** and should be quoted inclusive of all taxes and duties, if any.
- 3.5 The rate to be quoted in Indian Rupees Only. Offers should be strictly according to our requirement / specification and scope of work, failing which it may not be considered.
- 3.6 The Party /Supplier/ Bidder must provide copy of GST Certificate, PAN & Bank Details along with the quotation/ tender.
- 3.7 Transportation of Chilled Milk and Finished goods will be borne by JMF. Insurance also will be borne by JMF. Arrangement for Unloading of Milk & Loading of Commodities should be done by party.
- 3.8 The WMP conversion shall have to be accomplished upto packaging stage as per the requirement. Packing of WMP will mean, filling in 25 Kg. Kraft Paper Bags with liner tying with thread, stitching of K.P. Bag. The packaging material shall be provided by the bidder itself.
- 3.9 It would be mandatory for the bidder / service provider to print the declaration like "Best Before" as per the packaging of various acts.
- 3.10 **Payment Terms:** The payment terms would be 100% within 30 days after receipt of the material and submission of bills after physical and quality verification.
- 3.11 The staff of the JMF /JMF authorized person shall have the right to inspect the bidder / service provider plant / office for checking quality of product manufactured / packed / supplied for JMF, as well as maintenance of plant, temperature of product kept in cold store, weight / quantities of packs, hygienic conditions in the plant or any other matter relating to product.
- 3.12 The rejected material, if any, shall be lifted by the supplier at their own cost within a week time from the date of intimation from JMF. JMF shall not be responsible for any deterioration due to delayed lifting of the rejected material by the supplier.
- 3.13 The tender document submitted by a tenderer shall become the property of the Federation and the Federation shall have no obligation to return the same to the tenderer.
- 3.14 In case of any dispute, arising out of the contract, the same will be referred to sole arbitration of M.D., Jharkhand State Cooperative Milk Producers' Federation Limited or his authorized representative whose decision in the matter will be final and binding on both the parties. For all legal matters & dispute Ranchi court shall be our jurisdiction.
